Payment in full of the stud fee is expected at the time of first service, unless agreed upon puppy back.

 X Stud Fee: \$_____ **(Non-Refundable)**

Our service is to provide you with good quality, live, healthy, motile semen for your use. This is what you are paying for. There is much involved in this process which costs us money, time, and limits the use of our male for others. Conception after live, motile semen is delivered or inseminated is the sole responsibility of the Bitch owner and or your veterinarian. There must be accurate timing, proper procedures, and ovulation with eggs dropped in order for the semen to do its job.

We provide a repeat breeding only if proper Progesterone Testing was done, and at no cost to purchaser except shipping expenses. Bitch owner is to notify Stud Dog Owner 10 days before whelping, that the bitch is not bred & is to be due a repeat breeding. Failure to notify STUD DOG owner constitutes a null and void contract. A letter from a certified Veterinarian shall be provided to the STUD DOG owner for proof the bitch is not bred and for records in her file. If after the 2nd breeding the bitch does not conceive no further

specimens will be provided & the stud dog owner will advise bitch owner to have an implant done on the bitch to conceive.

Both parties agree that if the stud dog dies or is not on the premises for breeding or is being used by another bitch at the time of repeat breeding, the Stud Dog owner will have the right to breed to another like male of their choice.

Both parties agree that if the bitch changes ownership the stud service will be null and void.

- Three Generation Pedigree
- Brucellosis test—negative—signed by vet
- All current vaccinations
- DNA test (if available)

NO offspring from this mating will be sold, given or donated to pet shop, research lab/facility, grooming facility/parlor, or humane society.

The owner of female has to provide the phone number of clinic when is time for the c-section with 5 days before surgery and notify us when the female is ready.

The owner female have to send pictures in the moment of born the puppies to the owner of the stud services before to leave the clinic and the owner of the stud services will pick up the puppy when the puppy have 2 months old not before. (in case the deal will be puppy back)

Both parties agree that 1 live puppy constitute a litter. In this case the puppy will be sell and 50% is for the owner of female and the other 50% is for owner of the stud services. Failure to raise the litter does not constitute a repeat breeding. Both parties agree that their own

We require GOOD photos of any produced puppies for our studs Services Records and to verify the litter. We reserve the right to use any & all photos in any way we choose.

*At that point, we will pick our puppy. If our pick puppy dies or gets sick, then the picking process will start over again even if you have promised puppies or fell in love with one of them. (in case the deal will be puppy back)

We are counting on you to keep our puppy healthy & alive. (in case the deal will be puppy back)

*Until it is delivered to us in good health & condition, your stud fee is not paid. (When is Puppy Back the option)

*You are also responsible for delivering the puppy to Sandov's English Bulldog: Gilbert Sandoval (Riverside CA) at your cost and with a Flight Nanny, NO ground or cargo shipping. (in case the deal will be puppy back)
